#### 1. Mode of Meeting

- a. The Twenty-Fifth Annual General Meeting ("25th AGM") of the Company will be conducted on a fully virtual basis via Remote Participation and Voting facilities ("RPV") from the online meeting platform provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") at https://tiih.online.
- b. An online meeting platform can be recognised as the meeting venue or place under Section 327(2) of Companies Act 2016 if the online platform is located in Malaysia.

# 2. Remote Participation and Voting Facilities ("RPV")

- a. Members or proxies or authorised representatives or attorneys are to participate, speak (in the form of real time submission typed texts) and vote remotely at the 25th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>, including to pose questions to the Board or Management of the Company. Please refer to the Procedures for RPV.
- b. A member who has appointed a proxy(ies) or attorney(s) or authorised representative(s) to participate at this 25th AGM via RPV must request his/her proxy(ies) or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at <u>https://tiih.online</u>. Please refer to Procedures for RPV.
- c. As the 25th AGM is a fully virtual AGM, members who are unable to participate in this AGM may appoint Chairman of the Meeting as his/her proxy and indicate the voting instructions in the proxy form.

#### 3. Procedures for RPV

Member(s) or proxy(ies) or authorised representative(s) or attorney(s) who wish to participate the 25th AGM remotely using the RPV are to follow the requirements and procedures as summarized below:

Member(s) or proxy(ies) or authorised representative(s) or attorney(s) are required to pre-register their attendance for the 25th AGM to ascertain their eligibility to participate the 25th AGM using the RPV.</li> <li>Login with your user ID and password and select the corporate event: "(REGISTRATION) EIG 25TH AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select "Register for Remote Participation and Voting".</li> <li>Review your registration and proceed to register.</li> <li>System will send an e-mail to notify that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the Record of Depositors as at 22 September 2022, the system will send you an e-mail after 26 September 2022 to approve or reject your registration for remote participation is not approved, you will also be notified via email.</li> <li>(Note: Please ensure to allow sufficient time required for the approval as a new user of TIIH Online and participate the 25th AGM remotely).</li> </ul>

Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) EIG 25TH AGM" to engage in the proceeding of the 25th AGM remotely.</li> <li>If you have any question for the Chairman/Board, you may use the query box to transmit your question. If time permits, the Chairman/Board will endeavour to respond to questions submitted by you during 25th AGM. If there is time constraint, the responses will be e-mailed to you at the earlier possible, after the meeting.</li> </ul>
5.	Online Remote Voting	<ul> <li>Voting session commences from 2.30 p.m. on Wednesday, 28 September 2022 until a time when the Chairman announces the end of the session. Select the corporate event: "(REMOTE VOTING) EIG 25TH AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>
6.	End of Remote Participation	• Upon the declaration of the poll results and announcement by the Chairman on the closure of the 25th AGM, the live streaming will end.

# Note to users of the RPV facilities:

- a. Should your registration for RPV be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- b. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.
- c. #### 4. Appointment of Proxy or Attorney or Authorised Representative

Member(s) who appoint proxy(ies) to participate via RPV at the 25th AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means no later than **Monday, 26 September 2022** at **2.30 p.m.** 

The appointment of a proxy may be made in a hard copy form or by electronic means in the following manner:

(i) In hard copy form

In the case of an appointment made in hard copy form, the proxy form must be deposited with the Company's Registered Office at Lot 11, Jalan Astaka U8/88, Bukit Jelutong, Seksyen U8, 40150 Shah Alam, Selangor, Malaysia.

(ii) By electronic form

The proxy form can be electronically lodged via **TIIH Online** at <u>https://tiih.online</u>. Kindly refer to the Procedure for Electronic Submission of Proxy Form.

Please ensure ALL the particulars as required in the proxy form are completed, signed and dated accordingly.

Any authority pursuant to which such an appointment is made by a power of attorney must be deposited with the Company's Registered Office at Lot 11, Jalan Astaka U8/88, Bukit Jelutong, Seksyen U8, 40150 Shah Alam, Selangor, Malaysia not later than **Monday**, **26 September 2022** at **2.30 p.m.** to participate via RPV in the 25th AGM. A copy of the power of attorney may be accepted provided that it is certified notarially and/or in accordance with the applicable legal requirements in the relevant jurisdiction in which it is executed.

For a corporate member who has appointed a representative, please deposit the **ORIGINAL/DULY CERTIFIED** certificate of appointment not later than **Monday**, **26 September 2022** at **2.30 p.m**. to participate via RPV in the 25th AGM. The certificate of appointment should be executed in the following manner:

- (i) If the corporate member has a common seal, the certificate of appointment should be executed under seal in accordance with the constitution of the corporate member.
- (ii) If the corporate member does not have a common seal, the certificate of appointment should be affixed with the rubber stamp of the corporate member (if any) and executed by:

(a) at least two (2) authorised officers, of whom one shall be a director; or

(b) any director and/or authorised officers in accordance with the laws of the country under which the corporate member is incorporated.

# 6. Poll Voting

Pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, voting at the AGM will be conducted by poll. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Members/proxies/authorised representatives/attorneys can proceed to vote on the resolutions at any time from the commencement of the 25th AGM at **2.30 p.m.** on **Wednesday, 28 September 2022** but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to item (5) of the above Procedures for RPV for guidance on how to vote remotely from TIIH Online website at <u>https://tiih.online</u>.

Upon completion of the voting session for the 25th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

# 7. General Meeting Record of Depositors

For purpose of determining who shall be entitled to attend this meeting, the Company shall be requesting Bursa Malaysia Depository Sdn Bhd to issue a Record of Depositors as at **22 September 2022** ("General Meeting Record of Depositors") and only a Depositor whose name appears in the General Meeting Record of Depositors shall be entitled to attend this meeting.

#### 8. Pre-Meeting Submission of Questions to the Board of Directors

Members or proxies or authorised representatives or attorneys may submit questions for the Board in advance of the 25th AGM via Tricor's **TIIH Online** website at <u>https://tiih.online</u> by selecting "e-Services" to login, pose the questions and submit electronically not later than **26 September 2022** at **2.30 p.m**. The Board of Directors will endeavour to respond to the relevant questions at the 25th AGM.

#### 9. No Recording or Photography

No recording or photography of the AGM proceedings is allowed without the prior written permission of the Company.

There will be no distribution of food voucher or door gift to members or proxies or authorised representatives or attorneys
